How to Enter the RUNVAN® Air France Take Off Contest

- 1. Must be a Registered Runner in any 2016 BMO Vancouver Marathon event.
- 2. Registration must be made by February 29, 2016, 11:59pm (PST) to be eligible for the 'Take Off Contest Prize A' (with BikeHike Adventure), and by March 31, 2016, at 11:59pm (PST) to be eligible for the 'Take Off Contest Prize B' (with Air France).

ENTRIES

- 1. To enter, register for the 2016 BMO Vancouver Marathon with your full legal name, date of birth, city or town of residence, phone number, and email address, online at bmovanmarathon.ca.
- 2. To be eligible for the Grand Prize B, all entries must be received no later than March 31, 2016, 11:59pm (PST), through the online websites noted above.
- 3. Each race registration made by February 29, 2016, 11:59pm (PST) automatically earns one entry to win Prize A (with BikeHike Adventures).
- 4. Race registrations made by March 31, 2016, 11:59pm (PST) automatically entered to win Prize B (with Air France).
- 5. Entries that are fraudulent are not permitted and will be declared invalid. All entries that are incomplete, illegible, altered, mutilated, tampered with, submitted through illicit means, or do not conform to or satisfy any condition of these Contest rules will be declared invalid. Entries generated by a script, macro or other automated means are void. All entries become the property of the Vancouver International Marathon Society ("Society") and will not be acknowledged or returned.

WHO CAN ENTER

- 6. The Contest is open to Registered Runners only who has reached the age of majority in the province/state in which they reside by the end of the Contest Period.
- 7. The Contest is NOT OPEN to associates, officers, and directors of the Society, their advertising and promotion agencies, the suppliers of prizes or services related to the Contest, or their other representatives or agents, or anyone with whom any of the foregoing is domiciled.

THE PRIZE

Terms: For 1 traveler. Non-transferable. 12 Day land only tour, airfare not included. Trip offered as twin-share accommodation. Must be redeemed for a confirmed departure date. Custom dates not available for this contest. This contest excludes departure dates over Christmas, Easter and US Thanksgiving. Travel must be completed by February 28, 2017. Single supplement is available for an additional charge to contest winner.

9. Prize B is one (1) return economy airline ticket for two (2) adults from Vancouver International Airport to Europe with Air France. These Economy Class tickets must be issued by December 20, 2016, and must be used before February 29, 2017 (the last return date). No extension shall be granted and tickets are subject to availability at the time of booking. These tickets are for travel from Vancouver to Europe on Air France. Black-out dates are from December 10, 2015, to January 15, 2017. No stopover allowed in Paris, unless Paris is final destination. These tickets do not allow booking in a higher class of travel for a fee. These tickets are for personal use only and must be used simultaneously by two persons, one being the winner. Resale of these tickets is strictly forbidden.

Additional conditions apply per the attached '2016.M.BMOVM.Contest.Takeoff.AirFrance' document.

In the eventuality that the winner resides in a city that requires transportation to our departure cities, the costs associated to the transportation are the winner's entire responsibility. All travel documentation that may be required (visa, passports, etc.) are the winner's responsibility and must be obtained prior to departure. The Society strongly recommends the purchase of travel insurance. Taxes including destination and airport taxes as well as fuel surcharge are not included in the prize and are the responsibility of the prize winner. They must be paid at time of booking. The winner and accompanying traveler must have the same departure and return dates on the flight tickets.

- 10. The winners must be at least 19 years old.
- 11. The winner must respect the validity period of the prize and shall accept any alternatives presented if need be.
- 12. Prizes cannot be exchanged or substituted for cash.
- 13. Society reserve the right to offer a comparable product in the event of a program cancellation or change, Act of God or other unforeseen circumstances.
- 14. All personal expenses are the responsibility of the winners.

THE CONTEST DRAW

- 15. All current 2016 race registrations and are eligible for both Prize A and B
- 16. The Contest winner for Prize A will be drawn from eligible entries on March 1, 2016, at 3pm (PST).
- 17. The Contest winner for Prize B will be drawn from eligible entries on April 4, 2016, at 3pm (PST).
- 18. Following the draw, the selected entrants will be contacted at the email address or telephone number indicated on the Entry Ballot.
- 19. In order to be declared a winner, the entrant must:
 - a. Respond to the prize notification email or telephone call within 48 hours of transmission (if any selected entrant cannot be reached within 48 hours from the time of initial contact, an alternative entry may be selected);
 - b. Correctly answer, unaided, a time-limited, mathematical skill-testing question;
 - c. Sign the Society's standard declaration which states, among other things, that he/she:
 - i. has read, understands and complies with the Contest rules;



- ii. releases and discharges Society and its parents, subsidiaries and affiliates, the suppliers of prizes or services related to the Contest, and their respective advertising, promotion and production agencies and other agents or representatives
- iii. consents to the announcement of the winner's name and the use by or on behalf of Society of the winner's name, address, photograph, likeness, voice or statements for advertising and promotional purposes without any further compensation to the winner.
- 20. Should the declared winner not agree to the declaration above within 5 days of being selected, the applicable prize will be automatically forfeited and another entrant will be selected by random draw.
- 21. If the entrant is unable to travel, the prize may be transferred and rules apply to the transferred recipient.
- 22. The chances of winning depend upon the number of eligible entries received.

CONSENT TO PERSONAL INFORMATION USE AND DISCLOSURE

23. By entering the Contest, participants consent to the Society's collection, use and disclosure of the personal information provided in Contest entries for the administration of the Contest and in aggregated, non-personal form in order to create reports regarding Contest entrant demographics and consumer habits, which reports Society may disclose to others and/or use for further promotional purposes.

DISCLAIMER AND LIABILITY EXCLUSION

- 24. The Society, the suppliers of prizes or services related to the Contest, and their respective advertising, promotion and production agencies and other agents or representatives will not, under any circumstances, be responsible for, or liable to any Contest entrant or any other person for:
- a. any erroneous, lost, damaged, late, incomplete, misdirected, falsified, deleted, defective, or altered Contest entries, regardless of the cause;
- b. any failure for any reason whatsoever of the selected entrant to receive a prize notification email;
- c. any changes in email addresses or email address assignments after Contest entry forms are submitted;
- d. any computer, online, telephone, or technical malfunctions or errors that may occur, regardless of the cause; or
- e. any damage or loss, including any loss of use, loss of production, loss of profits (anticipated or otherwise), loss of markets, economic loss, special, indirect or consequential loss or damage or punitive damages, whether in contract, tort or under any other theory of law or equity, arising from, connected with, or relating to the Contest or the submission of entries to the Contest or participation in the Contest or the Contest prize,) and regardless of the cause or any negligence by Society or anyone for whom the Society is responsible, and notwithstanding that the Society may have been advised of the possibility of such loss or damage being incurred.

CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE ANY WEB SITE OR INTERFERE WITH THE LEGITIMATE OPERATION OF THE CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS, AND THE SOCIETY RESERVES THE RIGHT TO SEEK DAMAGES AND/OR OTHER RELIEF FROM ALL RESPONSIBLE PERSONS TO THE FULLEST EXTENT PERMITTED BY LAW.
- 27. Return of any prize notification email as undeliverable may result in disqualification, and an alternate winner may be selected.
- 28. Decisions of Contest judges in respect of any aspect of the Contest are final and binding on all entrants.
- 29. Participation in the Contest constitutes acceptance and agreement to these Contest rules.
- 30. The Society reserves the right, at their option, to publish the winner's name, address, photograph, likeness, voice or statements without any further compensation to the winner.
- 31. The Contest is subject to all applicable federal, provincial and local laws and is void where prohibited by law. If any provision of these rules is found by any court of competent jurisdiction to be unenforceable, all other provisions will remain in full force and effect.
